**GEOGRAPHICAL LIMITS:** Worldwide but excluding Iraq, Afghanistan, Burundi, Congo, Democratic Republic of Congo, Libya, Rwanda, Sierra Leone, Somalia, The Republic of Sudan, South Sudan, Checheno / Ingushskaya, Palestine and Yemen.

These limits have been extended to include Bujumbura, Brazzaville, Kinshasa, Lumbumbashi, Kisangani, Goma, Kolwezi, Tenke, Kigali, Freetown and Juba.

However, coverage is granted for the over flight of any excluded country where the flight is within an internationally recognized air corridor and is performed in accordance with International Civil Aviation Organisation recommendations or as advised by Air Traffic Control.

In addition to those countries listed above, coverage is excluded for any flight into any country where such operation of aircraft is in breach of United Nations Sanctions.
